## 2<sup>nd</sup> Annual Chautauqua Dog Show

The Chautauqua Dog Show is for all Fremont and surrounding area dogs of any age or breed as long as they fall within these guidelines.

### GUIDELINES

1. All entrants must be owner of dog with optional trainer to perform during the Show.

2. Dogs must:

- be fully potty trained.
- be current on vaccinations.
- remain on leash or in kennel.

3. Owners must:

- Remove all dog waste.
- Obey all City of Fremont ordinances.

- Be confident of dogs' behavior around people and other dogs. Dogs must not be aggressive nor pose a threat to the safety of other dogs, adults, and children nor to the tent grounds and structures.

### PUP'S BEST TRICKS COMPETITION

Each trainer will be allowed five minutes to showcase their dog's talents. They will be asked questions about their dog and background during the Show. (Example: nicknames, time in training, age of dog, age of trainer, etc) A rehearsal will be scheduled for 10:00am Thursday, the week of John C Fremont Days.

### DOGGY FASHION SHOW

Dogs must wear a cute and/or funny outfit or costume. Each dog will walk with owner or trainer to showcase the outfit. Owner will provide written information on outfit (example: Name of outfit or costume, where purchased or who made it, other anecdotes as desired) A rehearsal will be scheduled for 10:00am Thursday the week of John C Fremont Days.

First twenty (20) entrants will be accepted. This is a non judged show; winners will be drawn at random. More specific details will be texted/emailed to each participant prior to Show.
